At Autoliv, we care about the safety of your data. In this notice, you will find information about how we manage information about you and how to exercise your data protection rights.

WHO IS RESPONSIBLE FOR YOUR DATA?

Autoliv AB ("Autoliv"), registered with the Swedish Companies Registration Office under company number 556687-7345 and with registered office at Klarabergsviadukten 70, Section B7, 111 64, Stockholm, is processing your data on behalf of all legal entities in the Autoliv Group. Controllership and responsibility will be assumed by all Autoliv companies; please find a list of these at the end of this notice, in Annex No. 1.

WHAT PERSONAL DATA DO WE USE AND WHY?

Autoliv has contracted HubSpot Inc (HubSpot), a Software as a Service ("SaaS") company that offers a full platform and variety of software products for marketing, sales, customer service, operations, and CRM. Autoliv has adopted HubSpot CRM to standardize and automate prospects and customer relationship management, marketing campaigns, sales tracking, and customer support. This streamlines workflow ensures seamless and efficient data management processes, enabling better customer service and operational efficiency. HubSpot is the processors acting on behalf of Autoliv, the data controller.

Personal data is used to grant you access in HubSpot and to standardize and automate Autoliv's prospects & customer relationship management, marketing campaigns, sales tracking, and customer & user support. The detailed table below informs on how Autoliv is handling the data subjects' data in HubSpot:

WHO DO WE SHARE YOUR PERSONAL DATA WITH?

If we need to share your data, we ensure that such recipient processes it by this notice, such as by entering into data transfer agreements or data processing agreements with the recipients. Those agreements include all reasonable and appropriate contractual, legal, technical, and organizational measures to ensure that your information is processed with an adequate level of protection and following the applicable law. Categories of recipients include:

- Autoliv companies within the Autoliv Group are listed in Annex 1. To ensure the data management processes, enabling
 better customer service and operational efficiency, subject to the provisions of local law, the personal data and
 information you provide may be accessed, processed, and used by the relevant personnel of Autoliv or its affiliates or
 subsidiaries on need-to-know basis, including Management, Human Resources, Finance, IT, Internal Audit, Legal,
 Compliance, Marketing, etc.
- Third parties that Autoliv Group engages as processors. HubSpot CRM platform, along with the associated services (collectively referred to as the "Platform"), is provided by HubSpot Inc, a Software as a Service ("SaaS") company with global operations and with principal offices at 25 First Street, Cambridge, MA 02141, USA and their affiliates and subcontractors. These services are offered based on the terms agreed upon in our Corporate Agreement concerning our Subscription Service. The technical support is managed by a third-party IDX., a digital Communication and Marketing Company, corporation with principal offices at Gothenburg (the "IDX"). Generally, IDX acts as the partner and the primary contact for Autoliv inquiries. HubSpot, Inc and IDX are processors acting on behalf of Autoliv, the data controller.
- Subcontractors/consultants engaged by Autoliv to provide technical support under locally applicable laws (e.g. IDX Inc), including our affiliates and vendors which conduct operational, technology and customer or prospects service functions in various jurisdictions.

- Authorities and law enforcement agencies, if requested for audit purposes or to verify compliance with legal requirements
- Financial authorities for fraud prevention and other similar agencies, and other financial institutions, with whom information is shared for credit and money laundering checking and fraud prevention purposes
- Legal or professional advisers, where necessary for the establishment, exercise, or defense of legal claims.

We do not otherwise reveal your data to non-Autoliv persons or businesses for their independent use unless: (1) you request or authorize it; (2) the information is provided to comply with the law (for example, to comply with a search warrant, subpoena, or court order), enforce an agreement we have with you, or to protect our rights, property or safety, or the rights, property or safety of our employees or others; (3) the information is provided to our agents, vendors or service providers who perform functions on our behalf; (4) to address emergencies or acts of God; or (5) to address disputes, claims, or to persons demonstrating legal authority to act on your behalf; Those individuals and official authorities may be in one of the countries from Annex 1. If we need to share your data, we ensure that such recipient processes it follows this notice, such as by entering into data transfer agreements or data processing agreements with the recipients. Those agreements include all reasonable and appropriate contractual, legal, technical, and organizational measures to ensure that your information is processed with an adequate level of protection and following the applicable law.

HubSpot, Inc as third-party provider, might act as an independent data controller, according to their Privacy Policy for e.g.

- (a) when you sign up for their products and services, visit their websites or interact with them through other channels (for example in person events);
- (b) when they collect and process personal data about individuals in their professional capacity and make that information available to customers for their own sales, marketing, and other business activities. HOW DO WE ENSURE APPROPRIATE PROTECTION OF PERSONAL DATA WHEN TRANSFERRED ACROSS BORDERS?

Autoliv always ensures that the same high level of protection applies to your data according to the EU General Data Protection Regulation [Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons concerning the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC] and other applicable privacy acts, even when the data is transferred and processed outside of the jurisdiction you are operative in. Your rights concerning your data are not affected when data is transferred to a third country.

WHAT RIGHTS TO YOU HAVE RELATED TO THE PROCESSING OF YOUR DATA?

The right to have your data deleted

You have the right to ask us to delete personal data about you, for example, personal data that we no longer need for the purpose it was collected for, or personal data that we process based on a consent that you wish to revoke.

Right to be informed

You have the right to be informed of how we process your data. We inform you through this privacy notice, by general employee privacy notices issued from time to time, and by answering your questions at any given time.

Right to receive access to your data

You have the right to know if Autoliv processes personal data about you, and to receive a copy ("data extract") of such data. Through the data extract, you will receive information about what personal data we hold about you and how we process it.

Right to rectification

You have the right to request that we rectify inaccurate information or complete information about you that you consider is inaccurate or incomplete.

Right to restrict processing

If you believe that your data is inaccurate, that our processing is unlawful, or that we do not need certain information for a specific purpose, you have the right to request that we restrict the processing of such personal data. You also can request that we stop processing your data while we assess your request.

Right to object to our processing of your data

You have the right to object to processing your data, for example when the processing is based on legitimate interest,

by referencing your circumstances. When you object to our processing, you may also request us to restrict the processing of that personal data (as described above) while we make our assessment.

- Right to object to an automated decision that significantly affects you
 You have the right to object to our use of automated decisions or conclusions if the decision produces legal effects or
 significantly similarly affects you. Please note that no automated decision-making is being conducted within the scope
 of the survey.
- Right to withdraw your consent opt out. If marketing materials as newsletters etc are sent out to customers, there will always be an opt-out link the customer can access to block them from further notifications or send outs.

Where we process your data based on your consent, you have the right to withdraw that consent at any time. Autoliv will respect your decision by ceasing the processing of your data and discontinuing its use. For each internal competition/campaign organized by Autoliv a specific consent will be collected and a Privacy Notice will be made available at the Point of Data Collection to ensure transparency and compliance. Right to lodge a complaint

Our sales team uses the HubSpot mobile application during trade shows and events to efficiently manage business contacts. This app includes a business card scanning feature, which allows us to add contact information directly into our HubSpot system.

When your contact details are added, you will receive an email requesting your consent for the processing of your personal data. This includes consent for communication and, where applicable, marketing purposes. We will not use your data for marketing without your explicit permission.
